### Construction Products Regulation and CE Marking of Filon Profiled GRP Rooflights

From the 1st of July 2013 it became mandatory to CE mark any relevant products under the Construction Products Regulation that are covered by a harmonised European standard (hEN). Filon GRP translucent sheeting in all profiles, weights and fire grades fall under the requirements of *BS EN 1013:2012, Light transmitting single skin profiled plastic sheets for internal and external roofs, walls and ceilings - Requirements and test methods*. This standard was available for use from September 2013; from September 2014 it will be mandatory for profiled rooflights to be manufactured and marked in accordance with *BS EN 1013:2012*.

This standard not only includes GRP rooflights but also all other types of plastic profiled rooflight materials used for allowing light to enter into a building.

*BS EN 1013:2012* sets out the production requirements for the rooflights and outlines the *Declaration of Performance* of the products. It also changes the way profiled GRP is measured. Previously, profiled GRP has been manufactured to a weight per square metre based on the finished profiled sheet. This standard now alters the method of measurement to a weight in it's flat form, ie "Laydown Weight". The minor changes in weight will not affect the non-fragility of the products.

### Revised Naming of Filon Profiled GRP Rooflights

The tables below list the new references of Filon profiled GRP rooflights. For external sheets, a suffix of E is now included and indicates that the product incorporates a UV protective layer to the weather face. Although opaque coloured sheets do not fall under the requirements of *BS EN 1013:2012*, they are now manufactured in the same way and for consistency, the weight referencing has also changed to match the rooflight
